- **Call to Order**

- ❖ **NCORR**

presented **REBUILD NC the Community Development Block Grant -Disaster Relief (CDBG-DR) program overview**. This program is up and running. They are taking application for Hurricane Florence and Matthew cases mainly online at Rebuild.nc.gov or by phone 1-833-275-7262. The Power Point presentation will be posted on the NCVOAD web site (ncvoad.org). He noted that as volunteer organization have learned once the contract with Rebuild-NC is signed by the survivor there is a stop work order which prevents no-emergency (safety) work from being completed.

- ❖ **NC State EM**

❖ Team Rubicon

Laura Block presented **Staying Safe in COVID-19** She began with the disclaimer that as COVID-19 is a new disease and things are constantly being discovered and changing the policy therefore this presentation is what we knew up until yesterday (July 20, 2020). The presentation was a tutorial of how to safely and with military efficiency conduct volunteer operations during the COVID-19 pandemic. ❖ NC State EM

Keith Acree and Katie Webster presented **Preparing for Hurricane Season** Mr. Acree began the presentation focused on having your agency put together an information plan now so when an event happens the message can be easily managed. He referred to the State EM plan for messaging, which they would like you to use, that provides a simple consistent message about the different issues that arise during events (i.e. shelters, road closure, immediate treats). This type of social media messaging can hold off the unsupported social media messages that become an issue during the events. Ms. Webster picked up on the “know your zone” messaging campaign that the state is currently involved with. She noted the importance and the need to reach as many residents that are covered by the zones. The power point presentation will be made available on the NC VOAD web site (ncvoad.org).

George Strunk LTRG Committee Chair gave the report. He attended the Organization meeting in Buncombe county as they try to form a LTRG/COVAD. They are moving along and putting together a plan to address disasters weather, non-weather related and manmade. ➤ Emotional and Spiritual Care Committee

Dawn Baldwin Gibson Emotional and Spiritual Care Committee & Child Wellbeing Committee Chair gave the report.

Weekly reports from federal, state and local partners continue to be made by FEMA, NC Governor's Office, NC Emergency Management along with the American Red Cross, Catholic Charities, The Salvation Army, Inclusive Disaster to name a few

We have Emotional partners including Managed Care Organizations like Trillium Health Resources and other Mental Health Providers

We have Spiritual partners including state denominations such as United Methodists and AMEZ along with local churches throughout North Carolina

Over the past months, we have welcomed speakers such as

Dr. Diana Silimperi, an international public health pediatrician, epidemiologist and global health thought leader who is currently a visiting professor with the Duke Global Health Institute, Jil Christensen with Day One Disaster Relief who discussed about getting

supplies and PPE to marginalized, low wealth, rural and communities of color and Dr. Annie Hardison Moody is an Associate Professor at NC State University Dr. Hardison-Moody works in the emerging field of religion and health, with a focus on health and food. She specifically discussed Faithful Families Thriving Communities

which works directly in communities of faith across the country to promote health for individuals, families, and local communities. The practice-tested program is open to all faith and religious traditions and engages faith communities in health education, environmental changes to support health, and community-wide health initiatives. In April, a request for assistance came from the New Hanover County Emotional and

Spiritual Task Force about providing resources for Houses of Worship financially impacted by COVID 19 – specifically around since many had to go online virtually or were doing outside services. This request has become a significant issue as sustainability and viability of so many of these Houses of Worship has been questioned.

We have also had a director of the NC Council of Churches address the Partners in Health and Wholeness collaborative and mini grant program for faith-based organizations.

The Rural Center has also provided information for resources.

Dr. Danielle Laborde is President and Senior Epidemiologist at HERMES and provides technological and managerial direction for public health initiatives. She has secured tens of millions of dollars for public and mental health. She shared information for applying for federal funding.

Dr. Dawn is currently meeting with Duke Endowment about this issue.

This Task Force continues to work on connecting Houses of Worship with needed PPE – currently on getting masks in our rural communities.

As we have entered the hurricane season, the Emotional and Spiritual Care and Wellness Task Force continues to urge preparedness. We are urging Houses of Worship to encourage congregants to plan and prepare NOW.

Currently we have asked partners to participate in -- The Hurricane Preparedness and COVID19 series on Wednesdays at 11 a.m during the month of July. Hurricane Season and COVID-19.

North Carolina Office or Recovery and Resiliency

Laura Hogshead the Chief Operating Office at NC Rebuild was given time to remind the group of NC Rebuild. The Rebuild.nc.gov website is up and accepting application. They have 18 centers spread out across the region affected by hurricane Matthew and Florence. Remember start the process early as there is a lot of red tape. The process can seem very slow if not submitted correctly.

Organization Reports

Reports are presented as submitted

- **NC Baptist on a Mission**

Tom Beam reported they currently are in week 2 of their 8 weeks mission to feed NC. They concluded their 6 weeks mission to feed three weeks ago. Had one week off and were given a contract for 8 weeks. They have 17 locations strategically stationed across the state. They receive two tractor trailers a week of food/ products for distribution. They are currently in planning with the State EM and Red Cross on how to safely, effectively and efficiently feed people if we were impacted by a hurricane.

Long Term Rebuild in Lumberton, Wilmington, New Bern, Duplin County, Pender County 100's of homeowners still coming forward for assistance

- **World Renew**

Bill reported they are still trying to figure out how volunteers can stay safe with COVID-19. They hope to be operating in Aug 2020 but have not confirmed any dates.

- **Fuller Center**

Emily reported they continue to receive requests for rebuilds. They are still in need of volunteers. They have had some local volunteers. They are excited that need week a group of 10 volunteers will be coming in town.

In 2019 FCDR rebuilt 22 storm damaged homes due to hurricane Florence in Craven County. Through the end of June 2020 FCDR has rebuilt 31 storm damaged homes due to hurricane Florence (15 in Craven County and 16 in Pamlico County) We continue to work with the Craven County Disaster Recovery Alliance (CCDRA), the Pamlico County Disaster Recovery Alliance and other non-profits to identify unmet needs. Presently we have 5 homes we are working on, 5 higher priority homes on the backlog, and 6 homes that are lower priority on our backlog. We have 6 homes scheduled so far in July that we will be assessing for possibly taking on a repair for the homeowner

- **Church World Services**

Daniela, reported they are still assisting family with cash assistance in areas that have been classically underserved (immigrants, migrant workers and refugee communities). They are working with grass roots organization with-in these communities. They are also still involved with disaster services. For Hurricane Florence, provided CWS grant to one partner, and facilitated linkages for two local partners to access ARC funds. Both of these supports were for immigrant and refugee survivors in more than 10 counties helping to replace lost household items including clothes, shoes, bedding, and children schoolbooks. For another LTRG (Cumberland) CWS provided technical support to strengthen operational and staffing systems that facilitated the implementation of a large project in partnership with Alliance Behavioral Healthcare. CWS is currently facilitating linkage of the LTRG (Robeson) with one of the donors in our CWS network for survivors of Florence.

CWS provides support to vulnerable communities to prepare for and recover from disasters, especially immigrant and refugee households including the undocumented. We collaborate with LTRGs, grassroots and other organizations. CWS provides disaster preparedness work that is carried out through webinars, in-person trainings and a host of printed and web-based resources (accommodating culture-centric needs accordingly).

With our Kits & Blankets Ministry, CWS makes available for immediate assistance following a disaster our Kits (hygiene, school, and buckets) and Blankets. Any organization can request these items using the CWS Online Request form (@ <https://cws.tfaforms.net/437165>). For long term recovery assistance, when funds are available, CWS works through local organizations to provide material assistance for long term recovery support. Our goal is to increase resiliency of vulnerable refugee and immigrant populations affected by domestic disasters through disaster preparedness and early and long-term recovery efforts.

- **[Samaritan's Purse](#)**

Keeth Willingham reports New construction and homes repaired – 94 New Bern and Whiteville/Lumberton sites are utilizing Day volunteers with limited overnight volunteer opportunities.

- **[Christian Responders Ministry](#)**

Joe George reported assisted NCCUMC approximately 2.5 years in Lumberton with restoration, donations, clothing, materials, equipment and supplies. Assisted the local Catholic Church and made donations to Robeson County Church and Community Center as well as to the Lumberton Christian Care Center. Currently working on training in construction to increase our availability to different projects and increase our efficiency. Additionally, training in the safest ways to do this work during the era of COVID as well as training in having proper waivers on file for all volunteers.

- **[Sandhills Community Action Program INC](#)**

Nina Walker reported as of July 1, 2020, Sandhills Community Action Program began accepting applications from individuals and families that have unmet needs, as a result of Hurricane Florence. Funding is available in counties that were Presidentially declared disaster areas (Anson, Moore and Richmond County), for the Sandhills CAP service area. However, similar assistance is available in all 100 counties of NC and sponsored by each counties Community Action Agency.

- **[The Salvation ARMY -North & South Carolina Division](#)**

Mike Patterson reported for Hurricane Matthew: Response summary for NC only (does not include service delivery in SC): 296,313 meals, drinks and snacks; 7,629 hours of Salvation Army officer, employee and volunteer service; Emotional and spiritual care to 6,620 individuals; Emergency aid to more than 928 households with assistance such as gift cards, clean-up kits, food boxes, vouchers to TSA Family Stores, and referrals for a variety of services. Service delivery in recovery included coordination with other disaster case management agencies and organizations to leverage available resources and mitigate the duplication of efforts in addressing unmet needs; worked in collaboration with other community organizations and long term recovery groups to address unmet needs, particularly in the areas of Utility Bill Payments (Electric, Gas, Water) for those households reporting moderate to major property damage or disaster related loss of income; Home Repairs/Rebuild/Construction, coordination with other local providers to determine remaining unmet needs; Housing (Rent/Mortgage/Security Deposits) Assistance with housing stability costs when not covered by any other source.

Hurricane Florence: Response summary for NC only (does not include service delivery in SC): 652,533 meals, drinks and snacks; 74,504 hours of Salvation Army officer, employee and volunteer service; emotional and spiritual care to 17,744 individuals; emergency aid to more than 25,704 households with assistance such as gift cards, clean-up kits, food boxes, vouchers to TSA Family Stores, and referrals for a variety of

services. While providing disaster relief in impacted communities, some Salvation Army facilities were also directly impacted by the storm. In other areas, The Salvation Army continued to operate its regular programs and services, providing meals, emergency shelter, clothing, and energy assistance to residents in need who were not affected by the disaster. Service delivery in recovery included: Coordination with other disaster case management agencies and organizations to leverage available resources (including grants from the American Red Cross and Golden Leaf Foundation) and mitigate the duplication of efforts in addressing unmet needs; Working collaboratively with other community organizations and long term recovery groups to address remaining disaster caused unmet needs.

Current services being offered

1. Because human needs differ from state to state, city to city, and person to person, we find local solutions through support from the local community. Together, we feed, we shelter, we mentor, we rehabilitate, we rescue victims of human trafficking, we help disaster survivors, we provide hope. Meeting the needs of people in the name of Jesus Christ is the heart of The Salvation Army's work. We open our arms to serve people who are most desperate for physical, emotional, and spiritual care.
