



NC VOAD Quarterly Meeting. July 12, 2022, 10:00 AM Via Zoom Communications

- **Call to Order – Dr. Greg Lentz**

- **Dr. Greg Lentz –President’s Report**

Dr. Greg Lentz called the meeting to order with an introduction and provided the purpose and mission of the NC VOAD through the 4 C’s, the core principles of the NC VOAD (Cooperation, Communication, Coordination, Collaboration). He also shared that his 3-year term is ending after the 4th quarter this year and encouraged members from partner organizations to consider serving on the NC VOAD Board of Directors. He informed the attendees of his desire for the 4th Quarter meeting be held in person with a virtual option and inquired with Director Ann Huffman about the availability of the North Carolina Conference of The United Methodist Church facility site in Garner as a central location for the meeting to be held. Dr. Lentz proceeded to introduce the guest speaker, Director Annette Roper Taylor, Director of Digital Equity & Literacy, a new initiative from the Governor’s Office.

- **Director Annette Roper Taylor, Director of Digital Equity & Literacy**

Dr. Taylor provided an overview of Governor Cooper’s plan to build the broadband infrastructure across the state. She also informed the attendees about the Affordable Connectivity Program, a program that provides discounts on internet services to those who qualify. This program will provide sub-grants, devices, and support to non-profits for capacity building and developing a “Digital Inclusion Plan” to support marginalized communities across the state. \$12 million dollars has been appropriated for this initiative. Director Taylor’s power point presentation is attached.

Dr. Lentz introduced and welcomed new NC VOAD Member Duplin Christian Outreach Ministry. Board member Robert Moore provided some background on the organization adding that the group was a fiscal sponsor for the Duplin County LTRG.

- As Tropical Storm Colin showed us, tropical weather can form quickly with little notice. In addition, tropical weather does not always form in the ocean. As I am typing this there is an inland storm in the southeast that storm watchers are tracking that may move to the coast and bring with it severe weather. Make sure you and your volunteers stay weather aware. Sign up for local alerts and consider downloading FEMA's recently updated app.
- The mobile app— in English and Spanish — to give users increased personalization options and help them take charge of disasters. Downloading the app now is especially important as we enter peak hurricane and wildfire seasons. Please help us socialize the app by sharing this information with your constituents. To help with this, the FEMA App webpage has links to a social media toolkit and animation describing the app. Information on the app is attached.
- It is hot outside. There is hot, and then there is hot! Extreme heat is a period of high heat and humidity with temperatures above 90 degrees for at least two to three days. In extreme heat your body works extra hard to maintain a normal temperature, which can lead to death. Extreme heat is responsible for the highest number of annual deaths among all weather-related hazards.
