

NC VOAD Quarterly Meeting. January 10, 10:00 AM. North Carolina Emergency Management Command Center, 1636 Gold Star Dr. Raleigh, NC 27607 & Via Zoom Communications

• Welcome and Call to Order – NC VOAD Vice-President Reverend Roland Whitley

Reverend Whitley welcomed everyone in attendance vis Zoom and in-person. He reminded the zoom participants to remain muted unless addressing the group and welcomed everyone to utilize the chat function to introduce themselves and to share organization and contact information. He then reiterated the purpose of the VOAD explaining the 4 Cs of Communication, Cooperation, Coordination, and Collaboration.

• President Dr. Greg Lentz was unable to join the meeting from the field due to being out of the country and poor signal to call in.

• NC VOAD Secretary, Robert O. Moore

Secretary Moore presented to the group a proposal from the Board to amend the by-laws. Secretary Moore explained the reasoning behind the proposal was to provide more continuity and experienced leadership on the Board, especially the Executive members of the Board. He presented the following proposed changes as recommended by the Board. In accordance with ARTICLE V: BUSINESS FUNCTIONS: ARTICLE VII: AMENDMENTS you are hereby notified of the following:

ARTICLE VII: AMENDMENTS

- 7.1 Amendments of these By-Laws may be made by a vote of the membership present at any annual meeting, quarterly meeting, or special meeting called for that purpose. Membership must be notified and provided with proposed changes by the Advance Notice Period preceding such meeting. The By-Laws, as amended and adopted, shall serve as a set of rules that govern the internal administration and regulation of the affairs of the corporation.
- 5.6 The Advance Notice Period shall be ten (10) business days. PROPOSED AMENDMENT
- 5.2 From: The business of the corporation shall be managed by a Board of Directors of not less than five (5) nor more than nine (9) members, elected by a simple quorum of the membership at each annual meeting. Members of the Board of Directors shall serve staggered terms of three (3) years each. Notwithstanding the expiration of his or her term, each Director shall continue to serve in office until his or her

successor has been duly elected. A majority of the total number of Directors present constitutes a quorum for the transaction of business and voting purposes. 5.2 To: 5.2 The business of the corporation shall be managed by a Board of Directors of not less than five (5) nor more than ten (10) members, elected by a simple quorum of the membership at each annual meeting. Members of the Board of Directors shall serve staggered terms of five (5) years each. Notwithstanding the expiration of his or her term, each Director shall continue to serve in office until his or her successor has been duly elected. A majority of the total number of Directors present constitutes a quorum for the transaction of business and voting purposes.

After a discussion of Articles 6.1 and 6.2 of the By-laws, the group found that there were different interpretations of the by-laws regarding the term limits. It was further discovered there was no mention on having to have a gap year after a Board member had completed their 3-year term that prohibited a Board member from serving consecutive terms. The only term limit was to the Executive Board (President, Vice-president, Secretary, and Treasurer.

After the Treasurer's Report it was moved and properly seconded to vote on the proposed amendment. The proposal was defeated by a majority of those in attendance.

The big announcement we have at this moment is that with the help of Duke Energy Foundation, we were able to extend the NL contract. NCVOAD, in partnership with VolunteerNC, will be able to continue offering free access and usage of the platform for the next three years. This will help us determine if we need to keep the platform active, which is why we would like to encourage current users to help us increase donations exchange activities, and for those not yet registered, we encourage you to do so. NCVOAD and VolunteerNC plan on using NL as the primary platform for exchanging goods and services for future disasters, and we want to ensure you are all registered and know how to use the site. At this moment, the site is available in English and Spanish. However, NL has informed us that they can add other languages relatively quickly. So, let us know in advance if your organization requires access to the site in another language.

The SERT team reports a quiet year. We have participated regular NC VOAD exercises. Larry also furnished the following report:

Wake Interfaith Disaster Team Report to NC VOAD Annual Meeting January 10, 2003

Wake Interfaith Disaster Team continues to meet and train in the absence of a disaster. This past year we covered all the aspects of an LTRG during recovery including Crisis Cleanup, Emotional and Spiritual Care, Construction Management, Long-Term Recovery Workflow, Unmet Needs Committee, Case Management Best Practices, Volunteer Management, Outreach: When Intake

Slows to a Crawl, Donations Management, Disaster Case Management, and a Tabletop exercise covering the first weeks after a disaster.

2023 started off with a review of the services supported by FEMA Individual Assistance.

Wake Interfaith Disaster Team continues its long-standing practice of delivering a seminar on "Preparing an Emergency Operations Plan for Your House of Worship" on request by any House of Worship. Note that without such a plan and regular drills, congregants will do dangerous things in an emergency.

Rev. Nell Herring - representing Presbyterian Disaster Assistance shared that PDA continues to engage in long-term response in NC, KY, FL, and PR. PDA tends to engage in work related to volunteer management and emotional/spiritual

 - Reported that Catholic Charities are completing homes from Hurricane Florence.

- The American Red Cross is kicking off their Intermediate financial assistance program, called Bridge, in Florida following Hurricane Ian. This is important for us in North Carolina because this program has become a standard part of our Recovery program for medium to large scale disasters. In previous responses, this program was not standard and only offered in certain situations. With this change to our standard programs, we are able to consistently put more money in the hands of our clients after a disaster.
- As always, the winter months are busy for our Red Cross volunteers because it is our busy season for single family and multi-family house fires and other disasters. This program, provides care, comfort, and financial support to individuals immediately following those every day disasters. The ask we have for our VOAD partners is that as you are working within your communities, that you help ensure people know about this support because we can only provide this assistance when we are asked.
- We are preparing for a busy spring season working with our National Sound the Alarm campaign which focuses on installing smoke alarms in homes that have no working smoke alarms. This is a great way to work together with other VOAD partners to connect with vulnerable communities and ensure that people living within those communities have access to our preparedness services and free smoke alarm installations. While we are installing these alarms, we also take the time to educate individuals on other preparedness messages like hurricane or flood safety and how to develop a home fire safety plan.
- Lastly, across our two Red Cross regions in North Carolina we have our two Preparedness & Partnerships Managers (Adrian Mines & Melissa Hartzell) that you'll begin seeing more often at VOAD meetings and on these calls. They both work to ensure that we have strong local partnerships within their regions and can be valuable members of this team.
